

Aditya Birla Nuvo has announced that the Company jointly with Idea Cellular Limited has incorporated a new subsidiary for the aforesaid purpose in the name and style of 'Aditya Birla Payment Bank Ltd'.

Siti Cable Network's board has approved allotment of securities to promoter firms to raise Rs 830 crores through warrants and optionally fully convertible debentures (OFCDs).

Jet Airways Ltd: Jet Airways on Friday termed as "rumour" and "speculative" a news report claiming that UAE's national airline Etihad is set to raise its stake in the airline from 24 percent to 49 percent.

Suprajit Engineering has raised Rs 150 crores through a QIP amidst the turmoil in the markets, indicating that quality papers from performing companies have great demand from high net worth investors and fund houses.

National Fertilisers' board of directors of the company accorded in principle approval for equity participation of 11% in the revival of Sindri Unit of Fertiliser Corporation of India Ltd.

Maruti Suzuki India Ltd: India's biggest carmaker by sales, said it had suspended operations at its northern auto plants after protests disrupted the supply of some components.
