Cairn India: The tax department has agreed to lift the freeze on British oil explorer Cairn Energy being paid dividend by its erstwhile subsidiary Cairn India, but it still cannot sell the residual stake pending a tax dispute.

HDFC Bank has digitised payments at over 1,200 dairy co-operatives in the country under its Milk to Money (M2M) programme. The digitisation of dairy co-operatives has benefited 3.2 lakh farmers across 16 states, the private sector lender said in a statement here.
