Future Lifestyle Fashions has transferred its Lee Cooper business to a wholly-owned arm Future Speciality Retail Ltd by way of a slump exchange on a going concern basis.
NHPC: The government has sold equity shares worth Rs 1,950 crores in NHPC Ltd under buyback issue of the company. The Central government has sold 60.48 crores equity share.
Bharti Airtel: S&P Global Ratings on Wednesday said its rating on telecom operator Bharti Airtel is unaffected by the company's plan to sell 10.3% stake in its subsidiary Bharti Infratel, but added the deal will help improve its financial ratios.
RIL has completed sale of its entire 76% interest in its East African company GAPCO to Total SA of France for an undisclosed sum.
Thermax through its step down subsidiary in Denmark, has agreed to acquire 100% stake of Barite Investments, Poland.
Yes Bank announced that the Capital Raising Committee of the board of directors at its meeting held on March 29 has approved issue price of Rs 1500 per equity share for issuance of 3,27,11,000 equity shares to QIBs.
Siemens: A consortium of Siemens and Sumitomo Electric Industries has bagged an order of \$520 million from Power Grid Corp for supply of a high-voltage direct current (HVDC) transmission system.
Reliance Infra: Reliance Infrastructure InvIT Fund, which is planning a Rs 3,000-crore issue next month, has become the first to get approval from the National Highway Authority (NHAI).
