

Earnings today: IndusInd Bank, Sasken and YES Bank will announce their financial results for the quarter ended March 31, 2017 on Wednesday.

Nestle has collaborated with Google and Paytm's e-commerce platform Paytm Mall to roll out promotions for new variants of Maggi noodles.

Tata Steel is planning to write a cheque of £520 million (\$663 million) to its UK pensioners as a one-time settlement under a rarely used scheme, called the Regulated Apportionment Arrangement (RAA).

NTPC is considering pooling fixed charges for all its coal and gas based projects in a move that it claims will help maximise output from stations that generate low-cost electricity and reduce consumer tariffs.

ZEEL has completed the acquisition of 80% equity stake in Margo and consequently Margo has become a subsidiary of the company.

Indiabulls Real: NSE is looking into trading data of Indiabulls Real Estate following reports of alleged manipulation. Shares of the company have seen significant volatility in trading sessions in two days.

TCS posted 2.5% quarter on quarter (QoQ) fall in bottom line figures at Rs 6,608 crores for Q4FFY17. It had posted a net profit of Rs 6,778 crores in the sequential quarter ended December 31, 2016. Net profit of the company jumped 4.2% on a year-on-year basis.
