

Sterlite Tech reported a 16.3% jump in consolidated net profit to Rs 63.66 crores in the January-March quarter this year, mainly on account of demand for fibre to build high speed networks. The company had posted a net profit of Rs 54.75 crores in the quarter period a year ago.

Axis Bank reported a massive 43% plunge in the Q4FY17 net at Rs 1,225 crores on worsening asset quality woes, even though it managed to halve fresh dud asset formation. For full fiscal 2017, the private lender's net profit plummeted a whopping 52.7% to Rs 3,953.03 crores.
