CESC Ltd, a Rs 32,000 crores RP Sanjiv Goenka group flagship company, may consider business restructuring plan in today's board meet.

UFO Moviez reported a 9.9% increase in consolidated net profit at Rs 19.49 crores for Q4FY17. The company had posted a net profit of Rs 17.74 crores in Q4FY16.

Hindustan Copper's net profit jumped manifold to Rs 40.77 crores during Q4FY17. It had posted a net profit of Re.0.64 crore in the year-ago period.

Bajaj Finance has reported an increase of 43% in its net profit at Rs 449 crores for Q4FY17. The company had made a net profit of Rs 315 crores during Q4FY16.

Cosmo Films reported an increase of 16.8% in the consolidated net profit at Rs 28.15 crores for Q4FY17. It had posted a net profit of Rs 24.11 crores during Q4FY16.

Bajaj Finserv reported a growth of 3% in its consolidated net profit at Rs 535 crores in Q4FY17 as against Rs 518 crores in the year-ago period.

HUL posted 6.2% increase in standalone net profit to Rs 1,183 crores for Q4FY17, driven by robust sales across various business segments. It had had posted a standalone net profit of Rs 1,114 crores in the same period previous fiscal.

Dabur has acquired South African personal care companies D and A cosmetics and Atlanta Body & Health Products. The deal size is estimated at Rs 25 crores.

Indian Overseas Bank's net loss narrowed to Rs 646.66 crores in Q4FY17 due to reduction in provisions for bad loans. The bank had registered a net loss of Rs 936.19 crores in Q4FY16.

JSW Steel has drawn up capital expenditure programme of Rs 26,800 crores for the next three years period to expand capacity.

United Breweries reported a significant fall in standalone net profit to Rs 6.73 crores during Q4FY17 on higher expenses. It had posted a net profit of 52.37 crores in thQ4FY16.
