

Idea Cellular: CCI has approved the proposed merger between Vodafone India and Idea Cellular, which is seen as a key step in clearing the way for creating India's biggest phone company by subscribers.

Hero MotoCorp may report double-digit growth in the bottom-line figures for Q1FY18. Volumes may see 6% YoY recovery to 1.84 million units led by gradual recovery post demonetisation impact and stocking of inventory to meet festive demand starting next month.

Wipro has entered into a partnership with Hewlett Packard Enterprise (HPE) to offer IT infrastructure solutions in a consumption-based or pay-per-use business model for enterprises.

Ashok Leyland has bagged an order worth Rs 650 crores from KSRTC for 3019 buses. This order, one of the largest from a State Transport Undertaking for a single OEM, would be executed in the current financial year which would help the company in furthering its leadership position in buses.
