

Adani Ports will replace state-run iron ore miner NMDC Ltd on the National Stock Exchange's benchmark index Nifty from September 28.

Adani Enterprises Ltd: The flagship firm of the Adani Group, today said its shareholders have approved the proposal to raise up to Rs 6,000 crore through issuance of securities to sustain rapid business growth.

SBI has ruled out merging its credit card subsidiary into the bank or buying out its partner GE that has decided to exit the joint venture.

SAIL is planning to buy a 51% stake in Odisha government-run pig iron producer IDCOL Kalinga Iron Works, Parliament was informed today.

Tata Steel is continuing discussions to sell its loss-making long-products business in Europe, the company said on Wednesday, after talks with Swiss-based Klesch Group failed.

Nestle India Ltd: Government's claim from Nestle for selling "defective and hazardous" Maggi noodles may exceed Rs 640 crores as it is tabulating further damages to be sought, even as the company termed the class action suit as disappointing and an unprecedented step.

Coal India Ltd: Government will sell 10% stake in Coal India through a public offer, which could fetch about Rs 23,400 crores to the exchequer. The company said its first-quarter revenues rose 6.5% year-on-year to Rs 18,955 crores while net profit fell 6.7% to Rs 3,764.35 crores.

Reliance Infrastructure reported over 12.39% drop in its net profit at Rs 400.91 crores for the April-June quarter due to factors including higher finance cost and statutory payments related to Delhi Airport Metro.

Abbott India reported a 34.61% rise in its standalone net profit to Rs 68.56 crores for the quarter ended June 30, 2015.

GTL Infrastructure Ltd said its net loss widened to Rs.196.69 crores in the June quarter from Rs.156.12 crores a year ago due to higher provisions for doubtful advances and interest costs.

JSPL reported a consolidated net loss of Rs.339.26 crores for the April-June quarter owing to higher depreciation and finance costs.
