Ashoka Buildcon has fully acquired Ashoka Path Nirman Ltd. Highway developer Ashoka Buildcon has a portfolio of over 28 public-private partnership projects.

Shemaroo Entertainment plans to launch its movie premiere service 'Miniplex' on cable and online after partnering with two DTH players.

IIFL Holdings Ltd: Fairfax India Holdings, owned by Canadian billionaire Prem Watsa, has increased its stake in IIFL Holdings to almost 31%, making it the biggest shareholder of the financial services firm. Fairfax acquired 21.85% in IIFL through a recent voluntary open offer for roughly Rs1,340 crores.

Havells India may divest its majority stake in European lighting systems and fixtures company Sylvania, which it acquired in 2007 and became a global player.

Bharti Airtel will launch 4G services in Rajasthan within a few days and cover other important cities in next six months.

Dr Reddy's Laboratories has submitted response to the US Food and Drug Administration (USFDA) on Monday.

Electrosteel Steels Ltd: A consortium of 27 lenders, led by State Bank of India, have approved part conversion of Kolkata-based financially troubled Electrosteel Steels' about Rs.2,507 crores worth debt into equity shares under the SDR scheme..

Infosys Ltd: Infosys has spent only Rs.20 crores of its proposed Rs 400 crores (\$65 million) investment announced towards carbon-offset projects, announced in May this year. This is towards meeting a key sustainability goal of becoming carbon neutral by 2018.

Orchid Chemicals & Pharmaceuticals informed BSE that production operations of the company's bulk drugs plant located at Alathur, Tamil Nadu have been disrupted from December 2, 2015, due to flooding at the factory premises caused by heavy rains in Chennai.
