Strides Shasun Ltd: The Competition Commission of India has approved Strides Shasun's acquisition of two divisions of Sun Pharmaceutical Industries, said a media report.

Piramal Enterprises Ltd: The company announced sale of BST-CarGel from Piramal Healthcare (Canada) Ltd to Smith & Nephew, a global medical technology business.

State Bank of India said it is planning to monetise non-core assets and list some of its subsidiaries for meeting capital needs as well as global risk norms, Basel III, which will kick in from March 2019.

Pantaloons Fashion & Retail Ltd: The company which was acquired by Aditya Birla Nuvo Ltd (ABNL), on Tuesday announced change in its name to 'Aditya Birla Fashion and Retail Ltd'.

Crompton Greaves Ltd: Crompton Greaves Ltd has informed BSE regarding a Press Release dated January 12, 2016 titled "CG to power offshore wind farm in the Baltic Sea".

Tata Power Ltd: Tata Power Ltd said it has raised Rs 500 crore by issuing unsecured redeemable, taxable non-convertible debentures on private placement basis.

Godfrey Phillips: Japan Tobacco (JT), the world's third-largest listed tobacco company, is in talks to acquire a part of the promoter's stake in Godfrey Phillips India (GPI), said a media report.

Radico Khaitan Ltd: HSBC Global Investments Funds today reduced its stake in liquor firm Radico Khaitan to 5.89% after offloading shares in the open market.
