



Tata Motors Ltd: Jaguar Land Rover said on Wednesday that its second-quarter results will be affected by a blast at the Chinese port of Tianjin in August which destroyed or damaged many of the 5,800 vehicles the company had at the site.

Financial Technologies Ltd: Financial Technologies India Ltd (FTIL) on Wednesday said it has completed the sale of 11 per cent stake in Indian Energy Exchange (IEX) to DCB Power Ventures and Kiran Vyapar.

M&M Ltd: Auto major Mahindra and Mahindra (M&M) said it is aiming to gain a "respectable" market share in heavy commercial vehicle space and will further expand its presence in the utility vehicles segment.

HDFC Bank Ltd: Investigative agencies have traced the Rs 6,000-crore money laundering scam involving Bank of Baroda (BoB) to 11 accounts of HDFC Bank, said media reports.

Polaris Consulting & Services Ltd: Arun Jain, the founder chairman and mentor of Polaris Consulting & Services Ltd, is set to exit his two-decade-old company as discussions with Nasdaq-listed Virtusa Corp. to sell a controlling stake have reached the final stages.

RIL & ONGC: Degolyer and Macnaughton (D&M), a consultant based in Dallas, USA, in its preliminary report, has established continuity of reservoirs across oil and gas blocks owned by ONGC and RIL in the KG basin. It has also said some natural gas may have migrated from the state firm's block to one being operated by private explorer RIL.

Oil India Ltd: Efforts are on to control a major gas leakage at an Oil India Ltd (OIL) well in Rajasthan's Dandewala region, from where the highly inflammable gas has been oozing out for the last six days.

IVRCL Ltd: IVRCL Chengapalli Tollways Ltd. [ICTL], a Special Purpose Vehicle (SPV) formed by IVRCL Ltd for implementing the project, has begun collection of toll, said media reports.

Network18 Media and Investments reported a consolidated net loss of Rs 27.42 crore for the second quarter ended September 30. The company had registered a consolidated net loss of Rs 36.46 crore in the same period a year ago.

HUL lost 1.85 percent after profit in September quarter falling 2.6% and slower growth in revenue (4.1 percent) despite good volume growth of 7%.

DCB Bank plunged 20% after brokerages downgraded stock to sell due to new business strategy.
