Asian Paints Ltd: Asian Paints (International) Ltd has transferred the entire holding in its subsidiaries to Berger International Limited, Singapore to consolidate investments of the company in overseas subsidiaries.

Essar Steel Ltd: In a relief to Essar Steel India (ESIL), the Supreme Court has directed the Ruia-controlled company and New India Assurance Co to appoint an arbitrator to settle the dispute in a case involving about Rs 900 crore insurance claims against a 'terrorist' attack on the company's pipeline in Odisha.

Abbott India Ltd: Drugmaker Abbott Healthcare is challenging a state's accusation that a sample of the company's cough syrup contained excessive levels of codeine, the second multinational to question India's regulatory testing regime in recent months, said a Reuters report.

Havells India has said that devaluation of the yuan would not impact its business as exports form only 10% of the total sales.
