Hindalco Industries Ltd: Aditya Birla Minerals Ltd (ABML), a subsidiary of Hindalco Industries, will sell its closed copper mine in Queensland, Australia, to Lighthouse Minerals Holdings Pty for A\$15 million (Rs 70.5 crores) in cash and another A\$41.7 million (Rs 196 crore) in rehabilitation bond costs.

UB Holdings Ltd: After United Spirits, the auditor of UB Holdings has raised concerns over Rs 8,707 crores of corporate guarantees extended by the Vijay Mallya-owned holding company to the lenders of Kingfisher Airlines, said media reports.

Castrol India has decided to permanently close its Wadala plant in Mumbai where it was not carrying out any production.

State Bank of Mysore Ltd: SBM, an associate of SBI, cut the minimum lending rate by 0.10% to 9.90%.

NTPC is targeting to begin production from Pakri-Barwadih coal block in Jharkhand this year and three more blocks in next two years.

Amtek Auto has missed payments on the Rs 800 crores worth of bonds that matured on Monday, potentially exposing the Indian banking system to a near Rs 8,000 crores of loans which may have to be classified as bad loans if the company does not quickly make payments.
